**A RESOLUTION REQUESTING THE BACOOR CHAMBER OF COMMERCE AND THE LOCAL BUSINESS COMMUNITY TO DEVELOP AND IMPLEMENT A "ROLLING PALENGKE SYSTEM" AND "ROLLING BOTIKA SYSTEM" IN THE CITY OF BACOOR, CAVITE IN PARTNERSHIP WITH THE CITY GOVERNMENT, THE LIGA NG MGA BARANGAY, VARIOUS BACOOR HOMEOWNERS ASSOCIATIONS, NON-GOVERNMENT ORGANIZATIONS, AND OPERATORS OF PASSENGER UTILITY VEHICLES WITHIN THE CITY OF BACOOR, CAVITE TO REINFORCE SOCIAL DISTANCING MEASURES, ENSURE FOOD SECURITY, AND PROVIDE INCOME TO DISPLACED WORKERS DURING THE ENHANCED COMMUNITY QUARANTINE MADE NECESSARY BY THE CORONAVIRUS DISEASE 2019 (COVID-19).**







**WHEREAS**, as of 30 March 2020, the City of Bacoor already has fifteen (15) residents who tested positive with COVID 19 and the threat of more city residents getting infected by the dreaded disease grows exponentially every day.

**WHEREAS**, in an attempt to stave off the spread of the said disease, the national government placed the island of Luzon under an Enhanced Community Quarantine (ECQ) and required majority of the population to stay indoors except when buying food or medical supplies. However, the ECQ has disrupted the local economy of the City of Bacoor, Cavite and left drivers of various public utility vehicles without a source of income.









Some of those challenges are: (1) how to maintain social distancing whenever people flock to public markets, supermarkets, and drugstores to buy food and medical supplies, and (2) how to provide financial support to the families of the drivers of public utility vehicles within the City of Bacoor, Cavite.







Rowena Bautista-Mendiola duly seconded by all the members of the city council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in special online session duly assembled to request the Bacoor Chamber of Commerce and members of the business community of the City of Bacoor to develop and implement a "**ROLLING PALENGKE SYSTEM**" and a "**ROLLING BOTIKA SYSTEM**" in the City of Bacoor, Cavite in partnership with the city government, the Liga ng mga Barangay, various Bacoor homeowners associations, non-government organizations, and operators of passenger utility vehicles within the City of Bacoor, Cavite to reinforce social distancing measures, ensure food security, and provide income to displaced workers during the Enhanced Community Quarantine made necessary by the Coronavirus Disease 2019 (COVID-19).

**RESOLVED FURTHER**, the Head of the Business Permits and Licensing Office (BPLO), the Office of the City Administrator, the President of the Liga ng mga Barangay, and the General Services Officer of the City of Bacoor to coordinate with officials of the Bacoor Chamber of Commerce and key members of the local business community to implement the legislative intent behind this Resolution at the soonest possible time.







