**A RESOLUTION AUTHORIZING THE DISBURSEMENT OF AN ADDITIONAL EIGHT MILLION EIGHT HUNDRED NINETY-EIGHT THOUSAND THREE HUNDRED NINETY-TWO PESOS (PHP 8,898,392.00) FROM THE CITY DISASTER RISK REDUCTION MANAGEMENT FUND TO BE USED FOR THE CONDUCT OF OPERATIONS OF THE COVID-19 TASK FORCE AND OTHER RELATED EXPENSES.**

**WHEREAS**, the Sangguniang Panlungsod passed City Resolution No. CR 2020-182 on 18 March 2020 entitled: **A Resolution Authorizing the Disbursement of an Additional Three Million Seven Hundred Thousand Pesos (Php 3,700,000.00) from the Local DRRM Fund to be used for the Conduct of Operations of the African Swine Fever (ASF) Task Force**”;

**WHEREAS** the conduct of operations of the African Swine Fever (ASF) Task Force has been suspended indefinitely in line with the guidelines and protocols set forth by the Inter Agency Task Force on Managing Emerging Infectious Disease (IATF-MEID) in relation to the national effort to fight the 2019 coronavirus disease (COVID-19);

**WHEREAS**, the Bacoor Disaster Risk Reduction and Management Council has recommended the realignment of Three Million Seven Hundred Thousand Pesos (P3,700,000.00) originally appropriated under City Resolution No. CR 2020-182 for ASF operations to the funding requirements of the COVID-19 Task Force operations;

**Management Fund For Financial Assistance, Relief Goods, and Other Incidental Expenses Related to Relief and Rehabilitation Operations":**

**WHEREAS**, from the appropriation made by virtue of City Resolution No. CR 2020-187 of **Eleven Million One Hundred Ninety-Eight Thousand One Hundred Thirty-Four Pesos and Fifty Centavos (Php 11,198,134.50)**, only Five Million Nine Hundred Ninety-Nine Thousand Seven Hundred Forty Two Pesos and Fifty Centavos (Php 5,999,742.50) has been utilized to address the needs of the 304 families whose homes were razed in the fire incident in Barangay Zapote V;

**WHEREAS**, there is an unutilized amount of Five Million One Hundred Ninety-Eight Thousand Three Hundred Ninety-Two Pesos (P5,198,392.00) from the allocated amount intended for the fire victims of Barangay Zapote V;







**WHEREAS**, the Bacoor Disaster Risk Reduction and Management Council has recommended the realignment of the unutilized amount of Five Million One Hundred Ninety-Eight Thousand Three Hundred Ninety-Two Pesos (P5,198,392.00) for financial assistance, relief goods and other incidental expenses related to relief and rehabilitation operations for the fire victims in Barangay Zapote V to the funding requirements of the COVID-19 Task Force operations;
