**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH GOLDEN OASYS HOTEL FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOD.**

**WHEREAS**, the City Government of Bacoor is committed in doing its share in the national effort to fight the 2019 coronavirus disease (COVID-19) and to assist any person who may be infected by the said disease pursuant to Republic Act No. 111469 Republic Act No. 111469 (otherwise known as the "Bayanihan to Heal as One Act");

**WHEREAS**, on 04 April 2020, the City Legal Officer sent an endorsement letter through an electronic mail requesting the city council to pass a resolution authorizing the City Mayor, Hon. Lani Mercado Revilla, to sign a Memorandum of Agreement (MOA) with Golden Oasys Hotel (Golden Oasys) for and on behalf of the City Government of Bacoor.

**WHEREAS**, the City Government of Bacoor and the management of Golden Oasys agreed to designate the said hotel as one of the city government's temporary quarantine facilities for persons under investigation (PUMs) for COVID-19, especially but not limited to Bacoor residents who are arriving from abroad either from travel or from overseas contract work from a country that is declared by the World Health Organization (WHO) as having community transmission of the said disease.

**WHEREAS**, a draft copy of the Memorandum of Agreement to be entered into by the city government and by Golden Oasys was submitted to the Sangguniang Panlungsod for its review and consideration;
