CITY RESOLUTION NO. CR 2020-202
Series of 2020

A RESOLUTION EXTENDING THE PERIOD FOR SECOND QUARTER PAYMENT FOR FISCAL YEAR 2020 OF REAL PROPERTY TAXES, BUSINESS PERMIT RENEWALS, AND OTHER FEES, TAXES, AND CHARGES DUE FOR PAYMENT ON 20 MAY 2020 TO 30 JUNE 2020 PURSUANT TO SECTION 32 OF CITY ORDINANCE NO. 2013-060 OTHERWISE KNOWN AS THE "BACOOR REVENUE CODE".

WHEREAS, Section 32 of City Ordinance No. 2013-060 (also known as the "Bacoor Revenue Code") provides that:

"Time of Payment. – Unless otherwise provided in this Code, all taxes, fees and charges shall be paid within the first twenty (20) days of January or of each subsequent quarter as the case may be. The Sangguniang Panlungsod may, through a resolution, extend the time of payment without penalties for a period not exceeding six (6) months."

WHEREAS, President Rodrigo Duterte issued Presidential Proclamation No. 922, s. 2020, declaring the existence of a State of Public Health Emergency throughout the Philippines due to the spread of the Coronavirus Disease 2019 (COVID 2019).

WHEREAS, Presidential Proclamation No. 929, s.2020, was then issued by the President placing the island of Luzon under an Enhanced Community Quarantine and placing the Philippines under a State of Calamity.

WHEREAS, due to the foregoing presidential proclamations, the Bureau of Internal Revenue (BIR) issued Revenue Memorandum Circular No. 22-2020 on 18 March 2020 extending the filing of income tax returns and other taxes due to the national government on 15 May 2020. Consequently, City Resolution No. 2020-189 was passed by the Sangguniang Panlungsod extending the deadline for the payment of second quarter taxes to 20 May 2020.

WHEREAS, President Duterte extended the enhanced community quarantine to 15 May 2020 due to the continuing threat of COVID-19 on public health safety and publicly declared that the quarantine may still be extended depending on the number of people who will be infected with the disease.

WHEREAS, the extensive economic disruption caused by the enhanced community quarantine affected, and continues to affect, the ability of taxpayers to settle their various obligations to the government.

WHEREAS, on 02 May 2020, Mayor Lani Mercado-Revilla requested the Sangguniang Panlungsod through Atty. Maria Bernadette Carrasco (the City Legal Officer) to pass a resolution extending the time of payment of second quarter taxes and other fees from 20 May 2020 to 30 June 2020 pursuant to Section 32 of the Bacoor Revenue Code.



Rowena Bautista-Mendiola, unanimously seconded by the members, **BE IT RESOLVED** by the Sangguniang Panlungsod in online regular session duly assembled to pass a resolution extending the period for second quarter payment for Fiscal Year 2020 of real property taxes, business permit renewals, and other fees, taxes, and charges due for payment on 20 May 2020 to 30 June 2020 pursuant to Section 32 of City Ordinance No. 2013-060.
