WHEREAS, Mayor Lani Mercado-Revilla signed a Memorandum of Agreement on behalf of the City Government of Bacoor with Food Panda Philippines, Inc. for the implementation of the "Panda Toda-Bacoor" Project;

WHEREAS, the Sangguniang Panlungsod reviewed the said memorandum and unanimously decided to ratify the same.
