**A RESOLUTION REQUESTING CONG. STRIKE B. REVILLA TO REVIVE HIS PROPOSAL TO CONSTRUCT AN ELEVATED BIKE LANE SYSTEM TO BE KNOWN AS THE "RING OF LIFE PROJECT" IN THE CITY OF BACOR, CAVITE TO MITIGATE THE IMPACT OF COVID-19 ON THE COMMUTING PUBLIC.**

**WHEREAS**, on 25 May 2015, the Sangguniang Panlungsod passed City Resolution No. CR 2015-077 entitled: "A RESOLUTION ENDORSING THE BACOR RING OF LIFE PROJECT AS PART OF THE COMPREHENSIVE DEVELOPMENT PROGRAM OF THE CITY OF BACOR, CAVITE AND REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) AND THE PHILIPPINE ROAD BOARD TO PROVIDE FUNDS FOR ITS CONSTRUCTION IN ORDER TO IMPROVE ROAD SAFETY ALONG MOLINO BOULEVARD IN THE CITY OF BACOR, CAVITE".

**WHEREAS**, despite the obvious merit of the said project, the DPWH and the Philippine Road Board did not provide funds for the same.

**WHEREAS**, on 1 June 2020, Secretary Eduardo Año of the Department of Interior and Local Government (DILG) advised local government units to create bike lanes in their respective jurisdictions to aid the government in enforcing social distancing measures in public utility vehicles and allow people to travel to their places of work with minimal exposure to COVID-19.

**WHEREAS**, constructing bike lanes is not as simple as painting white lines on public roads as it requires the construction of a lane to be exclusively used by bicycles, segregated by barriers from the lanes reserved for motor





