A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE FOR REGION IV-A REGARDING THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM FOR THE YEAR 2020-2021 OF THE CITY OF BACOR.

WHEREAS, the Department of Social Welfare and Development (DSWD) is the government agency primarily responsible in delivering continuous social protection services aimed at eradicating poverty;

WHEREAS, the Supplementary Feeding Program (SFP) is the additional food to regular meals of the children ages 2 to 5 years old enrolled in Child Development Center (CDC) and Supervised Neighborhood Play (SNP). It is also part of the DSWD's contribution in the early childhood care and development program of the government.

WHEREAS, DSWD Memorandum Circular Nos. 4 and 12, Series of 2020 sanctioned the amended scheme of the implementation of SFP during the community quarantine period as astringent social distancing measures prohibit the conduct of assemblies or mass gathering which include the feeding of children in CDC and SNP;

WHEREAS, the City Government of Bacoor as partner of DSWD in the expeditious delivery of the social amelioration program, shall also assist in the implementation of SFP;

WHEREAS, funds transfer to Local Government Units is the best scheme to fast track the implementation of the program to the beneficiaries and shall be interim solution to the crisis situation due to COVID-19;

WHEREAS, the DSWD Field Office for Region IV-A and the City Government of Bacoor intends to execute a Memorandum
