A RESOLUTION ENDORSING THE CONSTRUCTION OF BACOOR RIVERWALK WITH BIKELANE-PHASE III TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THROUGH THE LOCAL GOVERNMENT SUPPORT FUND – ASSISTANCE TO CITIES (LGSF-AC).

WHEREAS, the national government appropriated Two Billion Four Hundred Eighty Nine Million Eight Hundred Thousand Pesos (PhP2,489,800,000.00) under the Local Government Support Fund-Assistance to Cities (LGSF-AC) for eligible programs and projects of local government units (LGUs) in the General Appropriations Act (GAA) for FY 2020;

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular (LBC) No. 123 which provided for the guidelines on the release of and utilization of Local Government Support Fund –Assistance to Cities (LGSF-AC) to local government units in the Fiscal Year 2020 General Appropriations Act, Republic Act No. 11465;

WHEREAS, LBC No. 123 requires, among others, that there is a Sanggunian Resolution endorsing the proposed priority programs and projects, and the same are part of the duly approved Local Development Investment Program (LDIP) and Annual Investment Program (AIP) of the LGU;

WHEREAS, the construction of the proposed Bacoor Riverwalk with Bikelane –Phase III by the city government will allow bicycle riders to safely travel while easing traffic volume on major roads and other thoroughfares within the City of Bacoor. The said proposed project is included in the LDIP and AIP of the City of Bacoor and falls squarely under the project menu provided under LBC No. 123;
