WHEREAS, on 06 May 2020, the City Peace and Order Council passed Resolution No. 01, Series of 2020 entitled: "A Resolution Approving the Realignment of Programs, Projects, Peace and Order and Public Safety (POPS) PLAN CY 2020 To Address the Corona Virus Disease 2019 (COVID-19) Situation" and it was submitted to the Sangguniang Panlungsod for review and approval;
