A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF UNDERSTANDING AND NON-DISCLOSURE AGREEMENT BETWEEN THE CITY GOVERNMENT OF BACOOR AND THE LANDBANK OF THE PHILIPPINES.


WHEREAS, the City Government of Bacoor, pursuant to the provisions of Republic Act No. 8792 (otherwise known as the "Electronic Commerce Act of 2000") is currently undertaking the modernization of its revenue collection systems to provide fast and efficient alternative payment collection services to the public;

WHEREAS, the Land Bank of the Philippines ("LANDBANK") designed and operated an online payment system called "LANDBANK Link.BizPortal" to allow clients to directly transact with the bank's payment gateway or allow partner-merchants to directly interface with the LANDBANK payment gateway, whichever is available and for WeACCESS, internet banking functionalities such as Balance Inquiry Bills Payment, Advice of Check Issued and Cancelled (ACIC) File upload, Loan Profile, Viewing Access to Online Collection (ONCOLL) Reports and Other Reports;

WHEREAS, under LANDBANK Link.BizPortal, the city government's clients may transact business and/or pay their monetary obligations to the City Government of Bacoor via internet using any of the ePayment models being offered by LANDBANK subject to the terms and conditions appurtenant thereto and, with the use of LANDBANK's WeACCESS, make online payment for the city's various recurring obligations such as national government remittances and utilities;

NOW THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola, duly seconded by the rest of the council, in 18th regular online session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to approve a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla, to sign a Memorandum of Understanding and Non-Disclosure Agreement for and on behalf of the City Government of Bacoor with the Land Bank of the Philippines to avail the Link.Biz Portal and WeACCESS Online Internet Banking Facilities and designate official users thereof. **PROVIDED that:** the following provisions of the draft Memorandum of Understanding and Non-Disclosure Agreement must be deleted before the City Mayor can exercise the authority granted herein, to wit:

"WHEREAS, Landbank has been chosen as the sole depository and financial settlement bank of LGU Bacoor City, subject to the following conditions mutually agreed upon by the PARTIES:"


