A RESOLUTION APPROVING THE REPROGRAMMING/REALIGNMENT OF VARIOUS INFRASTRUCTURE PROJECTS FUNDED FROM THE 20% DEVELOPMENT FUND FOR CY 2020 AND ALLOCATE THE SAME TO OTHER PRIORITIES OF CORONA VIRUS DISEASE (COVID-19) RELATED EXPENSES IN ORDER TO CONTINUE TO CURTAIL AND ELIMINATE THE THREAT OF COVID-19.

WHEREAS, on 22 July 2020, the Office of the City Mayor sent an endorsement letter to the Sangguniang Panlungsod requesting for the approval of the realignment of the funds intended for various infrastructure projects funded from the 20% Development Fund for Fiscal Year 2020, of the City of Bacoor in the amount of Forty Seven Million Nine Hundred Seventy Thousand Pesos (PhP47,970,000.00) and allocate the same to other priorities of Corona Virus Disease (Covid-19) related expenses in order to continue to curtail and eliminate the threat of covid-19 as approved by the Members of the City Development Council as enumerated in CDC Resolution No. 08, Series of 2020-REALIGN-SIP#6 passed on 21 July 2020;


