A RESOLUTION DIRECTING THE CHIEF OF POLICE OF THE BACOOR POLICE STATION TO: 1) STRICTLY IMPLEMENT THE VARIOUS IATF-EID GUIDELINES AND CITY ORDINANCES DESIGNED TO CURB THE SPREAD OF COVID-19 IN THE CITY OF BACOOR; 2) ARREST INDIVIDUALS WHO VIOLATED THE SAID GUIDELINES AND ORDINANCES IN ACCORDANCE WITH LAW; 3) OBTAIN THE ASSISTANCE AND COOPERATION OF VARIOUS BARANGAY OFFICIALS IN THE IMPLEMENTATION OF THE SAID GUIDELINES AND CITY ORDINANCES; AND 4) SUBMIT A WEEKLY ACCOMPLISHMENT REPORT TO THE SANGGUNIANG PANLUNGSOD REGARDING THE COMPLIANCE OF THE BACOOR POLICE STATION WITH THIS RESOLUTION.

WHEREAS, since the start of July 2020, an alarming increase in the number of COVID-19 positive cases in the City of Bacoor, Cavite was noticed by many local officials. As a matter of fact, the City of Bacoor now has a total of 735 COVID-19 positive cases as of 1 August 2020 - a number very much greater than what was recorded during the months of March to June 2020.

WHEREAS, members of the Sangguniang Panlungsod believe that the increase in COVID-19 cases in the City of Bacoor was due to several factors among which is the laxity of police authorities in the city in implementing the various guidelines of the Inter-Agency Task Force on Emerging Infectious Diseases (IATF-EID) designed your combat the spread of the said disease as well as various city ordinances on the same subject.


