WHEREAS, on 29 July 2020, the Office of the City Legal Officer sent an endorsement letter to the Sangguniang Panlungsod and requested to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla, to enter into a Data Sharing Agreement with the Department of the Interior and Local Government (DILG);

WHEREAS, the City Government of Bacoor is mandated pursuant to Item 7.4.1. of National Disaster Risk Reduction Management Council (NDRRMC) Memorandum Circular No. 19, S. 2016, or the Rules and Regulations Governing the Implementation of the Management of the Dead and the Missing Persons, to submit a report to the Regional Disaster Risk Reduction and Management Council (RDRRMC) on the number and causes of deaths, location, initial actions taken and needs related to the Management of the Dead and Missing (MDM) within the prescribed period, copy furnished the DILG Regional Office;

WHEREAS, NDRRMC Memorandum Circular No. 19, S. 2016 was issued to ensure efficient, timely and well-coordinated actions in managing the dead, and to establish resource-sharing mechanisms among the key players in the MDM;

WHEREAS, the Data Sharing Agreement to be entered into by the City Government of Bacoor and by the DILG is to facilitate the proper verification, validation and reporting of all COVID-19 related deaths;

WHEREAS, both parties are directed to conduct daily reporting of COVID-19 related deaths and to ensure that





