A RESOLUTION APPROVING THE REPROGRAMMING/REALIGNMENT OF VARIOUS INFRASTRUCTURE PROJECTS FUNDED FROM THE 20% DEVELOPMENT FUND FOR CY 2020 AND ALLOCATE THE SAME TO OTHER PRIORITY PROGRAMS/PROJECTS/ACTIVITIES OF THE CITY GOVERNMENT OF BACOR.

WHEREAS, on 26 June 2020, the Office of the City Mayor sent an endorsement letter to the Sangguniang Panlungsod requesting for the approval of the realignment of the funds intended for various infrastructure projects funded from the 20% Development Fund for Fiscal Year 2020, of the City of Bacoor in the amount of Thirty Three Million Three Hundred Fifty Five Thousand Pesos (PhP33,355,000.00) and allocate the same to other priority programs/projects/activities of the city government as approved by the Members of the City Development Council as enumerated in CDC Resolution No. 06, Series of 2020-REALIGN passed on 25 June 2020;

WHEREAS, there are existing problems in the implementation of the infrastructure projects as describe below:
