
WHEREAS, the PCSO provides Local Governments Units (LGUs) with a portion of the charity funds generated from the sales of Lotto and STL within their jurisdiction, as share for LGUs to be used by them for their medical and health related services;

WHEREAS, the PCSO also provides Calamity Assistance to LGUs in times of natural calamities and disasters, including those caused by outbreaks, epidemics and pandemics under the Calamity Assistance Program of PCSO;

WHEREAS, the City Legal Officer submitted a draft Memorandum of Agreement regarding the grant of the said Calamity Assistance by the PCSO to the City Government to the Sangguniang Panlungsod for its review and consideration;





