LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACORR WITH THE DEPARTMENT OF HEALTH- CALABARZON (DOH-CALABARZON) FOR THE DOWNLOADING TO THE CITY GOVERNMENT OF THE FUNDS EARMARKED FOR THE PURCHASE OF LAND BESIDE THE SOUTHERN TAGALOG REGIONAL HOSPITAL (STRH).


WHEREAS, Local Government Code of 1991 also requires the National Government or the next higher level of local government units (LGUs) may provide or augment the basic services and facilities assigned to a lower level of LGUs when such services or facilities are not made available or, if made available, are inadequate to meet the requirements of inhabitants. Such shall be funded from the share of LGUs in the proceeds of national taxes and other local revenues and funding support from the National Government, its instrumentalities and government owned or controlled corporations which are tasked by law to establish and maintain such services or facilities;






WHEREAS, Republic Act No. 11233 , "An Act Upgrading Bacoor District Hospital in the City of Bacoor , Province of Cavite , into a Level III General Hospital , to be known as the Southern Tagalog Regional Hospital , under the direct supervision and control of the Department of Health , increasing its Bed Capacity form Ten (10) to One Hundred (100) , and Appropriating Funds Therefor " has been enacted on 20 February 2019;

WHEREAS, under R.A. 11233, the development of Southern Tagalog Regional Hospital (STRH) under the management of Department of Health (DOH) will need an allocation of about Two Hundred Million Pesos (PhP200,000,000.00) from the national budget to purchase additional land and to construct additional buildings;

WHEREAS, the City of Bacoor will benefit from the fast development of a tertiary hospital in STRH and the city government will be able to assist the DOH in the process of acquisition of land for expansion plan;

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Agreement to be entered into by the City Government of Bacoor and the DOH to the Sangguniang Panlungsod for its review and consideration;


NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola, unanimously seconded by the Body in regular online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani to sign and enter into a Memorandum of Agreement for and on behalf of the City Government of Bacoor with the Department of Health-CALABARZON (DOH-CALABARZON) for the downloading to the city government of the funds earmarked for the purchase of land beside the Southern Tagalog Regional Hospital (STRH).

RESOLVED FURTHER, to furnish the DOH, the Southern Tagalog Regional Hospital, the Office of the City Mayor, and all government offices concerned with copies of this resolution.

APPROVED this 14th day of September 2020 by the 4th Sangguniang Panlungsod of Bacoor in 25th regular online session duly assembled.





