A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) ON THE CONSTRUCTION OF ISOLATION FACILITIES AT THE BACOOR COLISEUM IN BACOOR CITY, CAVITE.

WHEREAS, the City Government of Bacoor requested the Department of Public Works and Highways (DPWH) to assist in the construction of isolation facilities and/or shelters for their frontliners and other healthcare workers at the Bacoor Coliseum through the "We Heal As One Off-site Dormitory for Medical Personnel" program of the national government to alleviate the daily operational challenges being encountered by the city government during the COVID-19 crisis and to prevent further transmission of the disease to others living in the same household as the infected;

WHEREAS, in relation to the said request, the City Legal Officer submitted a draft Memorandum of Agreement to be entered into by the City Government of Bacoor and by the DPWH to the Sangguniang Panlungsod for its review and consideration with regard the conversion of the Bacoor Coliseum into a COVID-19 isolation facility;



WHEREAS, based on a presentation made by City Engineer Jicky Jutba at a public hearing conducted by the Sangguniang Panlungsod, it was claimed that the Bacoor Coliseum is the most feasible area within Bacoor City for use as a COVID-19 isolation facility and that the conversion of the said facility could be readily implemented.

WHEREAS, it is provided in the proposed MOA that the DPWH shall undertake the preparation of the conceptual plan of the proposed isolation facility/off-site dormitory as well as the procurement and the corresponding construction management and supervision of the project;

WHEREAS, the members of the Sangguniang Panlungsod believe that the conversion of the Bacoor Coliseum into a COVID-19 isolation facility will greatly enhance the ability of the city government to curb the spread of the disease within the city.

NOW THEREFORE, upon motion of Councilor Roberto L. Advincula, duly seconded by the rest of the council in regular online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign a Memorandum of Agreement for and on behalf of the City Government of Bacoor with the Department of Public Works and Highways (DPWH) on the construction of isolation facilities in Bacoor Coliseum, Bacoor City, Cavite.

RESOLVED LASTLY, to furnish the DPWH, the Office of the City Mayor, and other government agencies concerned with copies of this Resolution.

UNANIMOUSLY APPROVED this 14th day of September 2020 at the City of Bacoor during the 25th regular online session of the 4th Sangguniang Panlungsod of the City of Bacoor.
