WHEREAS, on 21 August 2020, the Office of the Legal Officer requested the Sangguniang Panlungsod to pass a resolution authoring the City Mayor Hon. Lani Mercado Revilla to sign a Project Proposal Globe Telecom Inc. known as "Go WiFi";

WHEREAS, under the said proposal, Globe Telecom Inc. shall provide free, ad-supported internet services for 30 minutes per day to any person who shall enter the Bacoor City Hall and the various motels now being used by the city government as COVID-19 isolation sites. In exchange, the city government shall not charge rental fees from Globe Telecom for the various equipment that it would install in the said buildings. However, the electricity consumed by the said equipment will be shouldered by Globe Telecom;
