**WHEREAS**, in view thereof, the Sangguniang Panlungsod agreed in principle to create a technical working group that will assist the city council in formulating a codified ordinance that will regulate various activities in the City of Bacoor during the COVID-19 pandemic as part of the so-called "new normal".

Palabrica, unanimously seconded by the rest of the council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 4th Sangguniang Panlungsod of the City of Bacoor, Cavite in regular online session duly assembled to create a technical working group to be comprised of the following:
