**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT AMONG THE UNIVERSITY OF THE PHILIPPINES-MANILA, THE PHILIPPINE GENERAL HOSPITAL - CHILD PROTECTION UNIT (PGH-CPU), THE CHILD PROTECTION NETWORK FOUNDATION INC. (CPN), AND THE CITY GOVERNMENT OF BACoor REGARDING THE PARTNERSHIP FOR BARANGAY DIGITALIZATION SERVICE PROJECT OF BARANGAYS MOLINO II AND MOLINO III IN THE CITY OF BACoor, CAVITE.**

**WHEREAS**, the University of the Philippines-Manila (UPM) and the Philippine General Hospital - Child Protection Unit (PGH-CPU) established and currently maintains a Child Protection Unit at the Philippine General Hospital.

**WHEREAS**, the Child Protection Network Foundation Inc. (CPN) provides support to the Child Protection Unit at the Philippine General Hospital(PGH-CPU) and UPM in the delivery of medical, psychological and legal services to abused children.

**WHEREAS**, the UPM and PGH-CPU plans to develop satellite services in two (2) hotspot barangays in Bacoor City namely Molino II and Molino III that will facilitate access for patients to PGH-CPU services .

**WHEREAS**, the Digitalization Service Project of the UPM and PGH-CPU includes telemedicine for mental health, medical follow-ups and case management. Non-abused children needing other medical services can schedule for appointments by using the computer to access Online Consultation Request and Appointment (OCRA).

**WHEREAS**, the CPN will provide a computer desktop with webcam, telemedicine program/software and will train online




