A CITY RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH GET PHILIPPINES, INC. REGARDING ON THE INSTALLATION OF GET-PASS APP AND GETPRO MONITOR APP ON THE SMARTPHONES OF THE SECURITY GUARDS, RECEPTIONISTS OR AUTHORIZED PERSONNEL OF DESIGNATED AREAS, BUILDING AND BUSINESS ESTABLISHMENTS AS WELL AS THE OPERATORS AND DRIVERS OF TRANSPORT VEHICLES THAT ARE PART OF THE SMART AND SAFE TRANSPORT NETWORK SYSTEM IN THE CITY OF BACOOR, CAVITE.
