A CITY RESOLUTION ENDORSING THE PROCUREMENT OF VARIOUS SUPPLIES, SERVICES, EQUIPMENT, VEHICLES, AND OTHER GOODS IN RELATION TO THE IMPLEMENTATION OF COVID-19 RELATED ACTIVITIES BY THE LOCAL GOVERNMENT OF THE CITY OF BACOR, CAVITE TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR THE AVAILMENT OF THE LOCAL GOVERNMENT SUPPORT FUND –FINANCIAL ASSISTANCE (LGSF-FA) UNDER SECTION 4(Q) OF REPUBLIC ACT No. 11494 ALSO KNOWN AS THE "BAYANIHAN TO RECOVER AS ONE ACT" AMOUNTING TO FIFTY MILLION PESOS (PHP 50,000,000.00).
