CITY RESOLUTION NO. CR 2020-267
Series of 2020

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN BARANGAYS ALIMA AND SINEGUELASAN, CITY OF BACOR, CAVITE AND AUTHORIZING THE RELEASE OF TWENTY THREE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 23,500,000.00) FROM THE CITY DISASTER RISK REDUCTION AND MANAGEMENT FUND FOR FINANCIAL ASSISTANCE, RELIEF GOODS, AND OTHER INCIDENTAL EXPENSES RELATED TO RELIEF AND REHABILITATION OPERATIONS.

WHEREAS, a fire broke out in a house in Barangay Alima which rapidly spread to its adjacent houses both in Barangay Alima and Barangay Sineguelasan in the evening of 1 November 2020 resulting in massive damage to property and the displacement of around 848 families whose houses were destroyed.

WHEREAS, the Bacoor City Disaster Risk Reduction and Management Council (CBDRRMC) passed Resolution No. 12, Series of 2020 dated 02 November 2020 requesting the Sangguniang Panlungsod to declare the existence of a state of calamity in Barangays Alima and Sineguelasan, City of Bacoor, Cavite and authorizing the release of **Twenty Three Million Five Hundred Thousand Pesos (Php 23,500,000.00)** from the City Disaster Risk Reduction and Management Fund.

WHEREAS, a copy of the said CBDRRMC Resolution No. 12-S-2020 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.


