A RESOLUTION EXTENDING THE GRANT OF TWENTY PER CENT (20%) DISCOUNT ON REAL PROPERTY TAX CURRENT YEAR PAYMENTS UNTIL MARCH 31, 2021 FOR CALENDAR YEAR 2021 ONLY IN THE CITY OF BACOR, PROVINCE OF CAVITE.

WHEREAS, the Twenty Per Cent (20%) discount on Real Property Tax is granted up to only January 20 of the current year for advanced payments pursuant to Article 7, Section 17 (D) of Bacoor City Revenue Code of 2013;

WHEREAS, to prevent overcrowding at the Bacoor City Hall of taxpayers in the midst of the COVID-19 pandemic, the City Mayor requested the Sangguniang Panlungsod to extend the above-mentioned period until March 31, 2021.

NOW, THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola duly seconded by Councilors Roberto R. Javier, Hernando C. Gutierrez, Leandro De Leon and Victorio L. Guerrero, Jr. in its 33rd regular online session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to pass a resolution extending the grant of Twenty Per Cent (20%) discount on Real Property Tax current year payments until March 31, 2021 for Calendar Year 2021 only in the City of Bacoor, Province of Cavite.


