WHEREAS, under Republic Act No. 11494 (otherwise known as the "Bayanihan to Recover as One Act"), the Department of Social Welfare and Development (DSWD) is mandated to provide assistance through key social protection programs particularly the Assistance to Individuals in Crisis Situation (AICS) in order to mitigate the effects of the COVID-19 pandemic situation;

WHEREAS, the DSWD has been given the authority to distribute assistance or to transfer of funds to Local Government Units (LGUs) to facilitate the distribution of Assistance to Individuals Crisis Situation (AICS).

WHEREAS, the Office of the City Legal Service with the authority of the City Mayor submitted a draft Memorandum of Agreement (MOA) to the Sangguniang Panlungsod for its review and consideration.

WHEREAS, under the said proposed agreement, the city government will identify the persons in crisis situations residing in the City of Bacoor through the CSWD-Bacoor and concerned barangays for the fast track distribution to them of the AICS.
