CITY RESOLUTION NO. CR 2020-288

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT BETWEEN THE BUREAU OF FIRE PROTECTION (BFP) AND THE CITY GOVERNMENT OF BACOR ON THE ONLINE ASSESSMENT, COLLECTION AND REMITTANCE FOR FIRE SAFETY INSPECTION FEES FOR (A) BUSINESS PERMIT, (B) BUILDING PERMIT, AND (C) OCCUPANCY PERMIT.

WHEREAS, on 11 November 2020, the Office of the City Legal Service requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement (MOA) with the Bureau of Fire Protection (BFP) relative to the online assessment, collection and remittance for fire safety inspection fees for (a) business permit, (b) building permit, and (c) occupancy permit.

WHEREAS, Section 12 (h) of Republic Act No. 9485, as amended by Section 11 of RA 11032, gave the BFP the power to enter into agreements with cities or municipalities to allow the latter to assess and collect fire safety inspection fees;

WHEREAS, Section 11 Rule IX of the Implementing Rules and Regulations of RA 11032 has set the guidelines for Local Government Units (LGUs) to be designated as collecting agent;


WHEREAS, the execution of the said MOA will complete the City Government's Online Billing and Assessment System.

Palabrica duly seconded by the rest of the council in regular online session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement between the Bureau of Fire Protection (BFP) and the City Government of Bacoor pertaining to the online assessment, collection and remittance for fire safety inspection fees for (a) business permit, (b) building permit, and (c) occupancy permit.
