WHEREAS, on 20 November 2020, the City Mayor urgently requested the Sangguniang Panlungsod to pass a resolution concurring with the Real Property Tax (RPT) Contactless Alternative Method of Payment in the City of Bacoor as proposed by the City Treasurer, Atty. Jesson Labao, to prevent possible transmission of Corona Virus Disease 2019 (COVID-19) among the taxpayers and city treasury employees.


WHEREAS, the Office of the City Treasurer laid down the contactless alternative payment method step by step with authorized transacting banks like Landbank of the Philippines (LBP) and Development Bank of the Philippines (DBP) to immediately address the growing lines of property owners paying real property tax in the City Hall of Bacoor.

NOW THEREFORE, after careful deliberation, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by all the councilors present in regular online session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to pass a resolution concurring with the Real Property Tax (RPT) Contactless Alternative Method of Payment in the City of Bacoor, Province of Cavite.
