A RESOLUTION INTERPOSING NO OBJECTION TO THE OPERATION OF BRICKHARTZ TECHNOLOGY, INC. AS A BPO-SERVICE PROVIDER TO AN ONLINE OFFSHORE GAMING OPERATIONS OF THE PHILIPPINE AMUSEMENT GAMING CORPORATION (PAGCOR) AT BARANGAY NIOG III, CITY OF BACOR, CAVITE.

WHEREAS, Section 458, (3) of Republic Act. No. 7160 (otherwise known as the "Local Government Code of 1991") grants the Sangguniang Panlungsod the power, among others, to grant franchises, enact ordinances levying taxes, fees and charges upon such conditions and for such purposes intended to promote the general welfare of the inhabitants of the city and to regulate any business, occupation, or practice of profession or calling which does not require government examination within the city and the conditions under which the license for said business or practice of profession may be issued or revoked.

WHEREAS, Brickhartz Technology, Inc. is a domestic corporation duly organized and existing under and by virtue of Philippine laws.

WHEREAS, the applicant intends to operate as a BPO Service Provider to the Philippine Amusement Gaming Corporation (PAGCOR) to its online offshore gaming clients particularly located at Barangay Niog III, City of Bacoor, Cavite.

WHEREAS, after a thorough deliberation of the said matter, majority of the members of the Sangguniang Panlungsod of Bacoor City, Cavite decided not to pose any objection to the granting of a business permit by the City Mayor to the applicant to allow the latter to operate as a BPO-Service Provider of an online offshore gaming operations of the PAGCOR at Barangay Niog III, the City of Bacoor, Cavite

NOW, THEREFORE, upon motion of Councilor Michael Solis unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod not to pose any objection to the granting of a business permit by the City Mayor to the applicant for the latter's operation as a BPO Service Provider to an online offshore gaming operations of the PAGCOR at Barangay Niog III, City of Bacoor, Cavite provided that the said applicant will strictly comply with the following conditions, to wit:

- a) the said business permit shall be effective for only one (1) year, which period shall be reckoned from the date of issuance of such business permit;
- b) the applicant shall not allow any minor, or any student in uniform irrespective of age, from entering, loitering, or playing bingo or other games of chance within the premises of the bingo hall/s that it intends to operate at Barangay Niog III, City of Bacoor, Cavite;
- c) the said business permit shall be limited within the City Bacoor, Cavite;
- d) the applicant must first obtain a Fire Inspection Safety Clearance from the Office of the Fire Marshall of Bacoor, Cavite before the said business permit can be issued;
- e) the applicant must submit its Certificate of Incorporation, Articles of Incorporation and By-laws as duly issued and/or approved by the securities and Exchange Commission (SEC) with the Business Permit and Licensing Office (BPLO) of the city government before a business permit can be issued to the Corporation;
- f) the applicant must submit to the BPLO and to the Office of the Secretary of the Sangguniang Panlungsod a certified true copy of its PAGCOR franchise.
- g) the applicant must pay any and all pending liabilities and taxes, which may include penalties or fines imposed against the Corporation by past municipal administrations, that it still
