**A RESOLUTION EXTENDING THE DEADLINES FOR PAYMENT OF TAXES, FEES AND CHARGES OF THE CITY GOVERNMENT OF BACOR PURSUANT TO SECTION 4 (TT) OF REPUBLIC ACT NO. 11494 ALSO KNOWN AS THE "BAYANIHAN TO RECOVER AS ONE ACT OF 2020" FROM DECEMBER 19 2020 TO 29 DECEMBER 2020.**

**WHEREAS**, the Department of Finance –Bureau of Local Government Finance issued Memorandum Circular No. 016-2020 dated October 30, 2020 and the Department of Finance issued Department Circular No. 003-2020 regarding the extension of deadlines for the payment of taxes, fees and charges of Local Government Units (LGUs) pursuant to Section 4 (TT) of Republic Act (RA) No. 11494 or the "Bayanihan To Recover As One Act of 2020".

**WHEREAS**, the circular aims to provide guidelines on moving the statutory deadlines and timelines for the filing and submission of any document, the payment of taxes, fees and other charges required by law and the grant of any benefit to ease the burden on individuals under community quarantine to severe disruption of economic activities brought about by COVID-19 pandemic;

**WHEREAS**, the said circular stated that the payment of all local taxes, fees and charges with statutory deadlines duly authorized and imposed by the city government that fall on or after September 14, 2020 shall be extended until 19 December 2020, but any further extension beyond 19 December 2020 shall be authorized in accordance with the provisions of Republic Act No. 7160 .

**WHEREAS**, on 14 December 2020, Mayor Lani Mercado-Revilla requested the Sangguniang Panlungsod
