




WHEREAS, on 14 December 2020, the Office of the City Legal Service requested the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to sign and enter into a Tripartite Agreement with the Department of Health (DOH) for the implementation of the Special Risk Allowance and Active Hazard Duty Pay under Republic Act (RA) No. 11494 or the "Bayanihan To Recover As One Act of 2020".

WHEREAS, Section 4 (h) of RA 11494 authorizes the national government to grant a "COVID-19 Special Risk Allowance to all public and private Health Workers (HWs) directly looking after to Corona Virus Disease 2019 (COVID-19) patients every month during the declaration of a state national emergency;








WHEREAS, the Office of the City Legal Service with the authority of the City Mayor submitted a draft Tripartite Agreement to be entered into by the City Government of Bacoor and the DOH to the Sangguniang Panlungsod for its review and consideration;

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola, unanimously seconded by the Body in special online session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani to sign and enter into a Tripartite Agreement for and on behalf of the City Government of Bacoor with the Department of Health-CALABARZON (DOH-CALABARZON) for the implementation of the Special Risk Allowance and Active Hazard Duty Pay pursuant to Republic Act No. 11494 otherwise known as the "Bayanihan To Recover As One Act of 2020".

RESOLVED FURTHER, to furnish the DOH, the Office of the City Mayor, the City Health Office, the Office of the City Treasurer, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and all government offices concerned with copies of this resolution.
