**A CITY RESOLUTION HONORING THE MEMORY OF THE LATE JUSTICE MANUEL PAMARAN FOR HIS EXEMPLARY AND DISTINGUISHED SERVICES AS WAR VETERAN, PUBLIC SERVANT, LAWYER AND EDUCATOR TO THE FILIPINO PEOPLE.**

**WHEREAS**, the Office of the City Legal Service requested the Sangguniang Panlungsod to pass a resolution honoring the memory of the late Justice Manuel Pamaran, a native of Bacoor who served as President of the Veterans Federation of the Philippines (VFP), a former justice of the Sandiganbayan and a World War II veteran who was known for his utmost integrity, dedication to duty and academic excellence.

**WHEREAS**, Pamaran was a law graduate at Manuel L. Quezon University and earned a Master of Law degree from Far Eastern University. He was appointed as Assistant Fiscal of Manila in 1965 then became a Court of First Instance Judge, and later on given the chairmanship of the Supreme Court Sub-committee on Evidence tasked with reviewing and revising the 1964 Rules of Court. He had an eight-year stint as a Sandiganbayan Presiding Judge from June 1978 to March 1986. He also served as a Legal Consultant to the Office of the Vice President from 1996 to 1998 and Presidential Assistant on Justice for the Office of the President from 1998 to 2001.

**WHEREAS**, Pamaran was also an educator. He served as Dean of the College of Law of the Pamantasan ng Lungsod ng Pasay and was also a lecturer at the University of the Philippines College of Law.





