A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACoor REGARDING THE INSTALLATION, MAINTENANCE AND PROTECTION OF TRASH TRAPS/ TRASH NETS IN IDENTIFIED BARANGAYS IN THE CITY OF BACoor.

WHEREAS, the Department of Environment and Natural Resources (DENR) is the primary government agency responsible for the conservation, management, development and proper use of the country's environment and natural resources;

WHEREAS, DENR Administrative Order No. 16, Series of 2019, entitled: "Expediting the Rehabilitation and Restoration of the Coastal Marine Ecosystem of the Manila Bay and Creating Manila Bay Task Force" directs the convergence of the national government agencies and the LGUs in the Manila Bay Region that includes the Province of Cavite and the active participation of private and public stakeholders which are necessary to facilitate the robust and integrated implementation of all the rehabilitation efforts at the Manila Bay;

WHEREAS, based on available studies and trials, trash traps/ trash nets had demonstrated high levels of effectiveness in trapping trash that goes into drains and waterways. Various tests done by the DENR revealed that such structures are effective in trapping in all kinds of garbage but it can only accommodate a finite quantity of waste and their maintenance and cleaning should be done

1. Salinas River Trash Net – Barangay Salinas I;
2. Meztiso River Trash Net – Barangay Habay I;
3. Molino V Trash Trap – Near Barangay Hall of Molino V;
4. Molino III/Molino VII Trash Trap – in between Barangay Molino III and Molino 7;
5. Panapaan VII/ Real II Trash Trap – in between Barangay Panapaan VII and Real II; and
6. Ligas Trash Trap – Barangay Ligas I

WHEREAS, a draft Memorandum of Agreement was submitted by the Office of the City Legal Service with the authority of the City Mayor to the Sangguniang Panlungsod for review and consideration:

Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement with the Department of Environment and Natural Resources (DENR) for and on behalf of the City Government of Bacoor regarding the installation, maintenance and protection of trash traps/ trash nets in the aforementioned barangays in the City of Bacoor.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the CENRO, the DENR, the aforementioned Barangays, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this resolution.


