WHEREAS, on 19 January 2021, the Office of the City Legal Service sent a letter requesting the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to enter into a Confidentiality Agreement with AstraZeneca Pharmaceuticals (Phils.), Inc. regarding the proposed transaction between the said parties related to the anti-COVID 19 vaccine known as "AZD1222" and its availability for distribution in the City of Bacoor and ensuring the confidentiality of the proprietary information that will be disclosed during the evaluation of the city government on the proposed transaction.

WHEREAS, the abovementioned matter was deliberated upon by the council and it was found beneficial to the residents of the City of Bacoor;


