A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE RECLAMATION AUTHORITY FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACoor ON THE PROPOSED BACoor RECLAMATION AND DEVELOPMENT PROJECT (BRDP)- INNER ISLAND PROJECT.

WHEREAS, on 05 February 2021, the City Legal Officer, Atty. Bernadette Carrasco, sent a letter requesting the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla to sign a Memorandum of Agreement with Philippine Reclamation Authority (PRA) on the proposed "Bacoor Reclamation and Development Project (BRDP) -Inner Islands Project" comprising, more or less 90 hectares of the foreshore and offshore areas of Bacoor Bay, adjacent to the Manila-Cavite Expressway (CAVITEX).

WHEREAS, the BRDP was approved by the PRA Governing Board - which was empowered by President Rodrigo Duterte to approve reclamation projects pursuant to Executive Order No. 74 issued on 01 February 2019-through Board Resolution No. 5242 after the city government submitted to the PRA all the requirements for the project including the Area Clearance (AC) and Environmental Compliance Certificate (ECC) issued by the Department of Environment and Natural Resources (DENR) for the First Phase of BRDP.

WHEREAS, the proposed MOA also provides that the city government - or its joint venture partner -shall pay the following to the PRA: (1) regulatory fees initially assessed at

One Hundred Sixty Million Seven Hundred Nine Thousand Nine Hundred Seventeen Pesos and 49/100 (Php 160,709,917.49); (2) a Social Environmental Fee initially assessed at Twenty Eight Million Six Hundred Ninety Eight Thousand One Hundred Ninety Nine Pesos and 55/100 (Php 28,698,199.55); and (3) a Supervision Fee initially assessed at Sixty Two Million One Hundred Thirty Six Thousand Six Hundred Seventy Pesos and 27/100 (Php62,136,670.27) within the periods specified in the said agreement.

WHEREAS, the proposed agreement further provides that the national government shall own 12.6% of the gross reclaimed land while the remaining 87.4% shall be owned by the city government and by Frabelle Fishing Corporation. However, the 12.6% share of the national government shall be wholly saleable while the 87.4% share of the city government/Frabelle Fishing Corporation shall inclusive of roads and open spaces.

WHEREAS, a copy of the said draft Memorandum of Agreement was submitted by the Office of the City Legal Officer with the authority of the City Mayor to the Sangguniang Panlungsod for review and consideration;

NOW THEREFORE, upon motion of Hon. Alde Joselito F. Pagulayan duly seconded by the rest of the council in regular online session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement with the Philippine Reclamation Authority (PRA) for and on behalf of the City Government of Bacoor on the Bacoor Reclamation and Development Project (BRDP)-Inner islands Project.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the PRA, the Frabelle Fishing Corporation, the Office of Rep. Strike B. Revilla, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government agencies concerned with copies of this resolution.
