A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 3 FOR THE SUPPLEMENTAL BUDGET NO. 1 OF THE CITY OF BACOR, PROVINCE OF CAVITE AMOUNTING TO FIFTY SEVEN MILLION EIGHT HUNDRED FORTY THOUSAND ONE HUNDRED THIRTY ONE PESOS (PHP57,840,131.00) FOR CALENDAR YEAR 2021.
