A RESOLUTION DIRECTING THE CHIEF OF POLICE OF THE BACOR POLICE STATION TO: 1) STRICTLY IMPLEMENT THE VARIOUS IATF-EID GUIDELINES AND CITY ORDINANCES DESIGNED TO CURB THE SPREAD OF COVID-19 IN THE CITY OF BACOR; 2) ARREST INDIVIDUALS WHO VIOLATED THE SAID GUIDELINES AND ORDINANCES IN ACCORDANCE WITH LAW; 3) OBTAIN THE ASSISTANCE AND COOPERATION OF VARIOUS BARANGAY OFFICIALS IN THE IMPLEMENTATION OF THE SAID GUIDELINES AND CITY ORDINANCES; AND 4) SUBMIT A WEEKLY ACCOMPLISHMENT REPORT TO THE SANGGUNIANG PANLUNGSOD REGARDING THE COMPLIANCE OF THE BACOR POLICE STATION WITH THIS RESOLUTION.

- 3) **OBTAIN THE ASSISTANCE** and cooperation of various barangay officials in the implementation of the said guidelines and city ordinances; and
- 4) **SUBMIT** a weekly accomplishment report to the Sangguniang Panlungsod regarding the compliance of the Bacoor Police Station with this Resolution.

**RESOLVED LASTLY**, to furnish P/Col. Christopher Guste, Bacoor City Police Station Chief, the COVID-19 Task Force of the City of Bacoor through the Public Information Office, the Office of the City Mayor, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and all government offices concerned with copies of this Resolution.
