A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE NATIONAL POLICE (PNP) – BACoor CITY REGARDING THE ADOPTION OF THE COMMUNITY AND SERVICE-ORIENTED POLICING (CSOP) SYSTEM.

WHEREAS, on 11 February 2021, the Office of the City Legal Officer sent a letter to the Sangguniang Panlungsod requesting for the approval of a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla, to sign a Memorandum of Agreement with the Philippine National Police (PNP) – Bacoor City regarding the Community and Service-Oriented Policing (CSOP) System.

WHEREAS, the City Government of Bacoor has been focused on systems improvement through different programs including the Cavite Police Provincial Office's *Community Mobilization Project (CMP)*, *Drug Free Home*, *Simula ng Pagbabago (SIPAG)* and other anti-criminalities plans.
