WHEREAS, a copy of the said CBDRMC Resolution No. 03-S-2021 was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and approval together with reports from the City Social Welfare Development Office (CSWDO) confirming the extent of the damage caused by the said fire.


