A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 4 FOR THE REPROGRAMMING/ REALIGNMENT OF SOME INFRASTRUCTURE PROJECTS OF THE CITY OF BACOR FUNDED FROM THE 20% DEVELOPMENT FUND FOR THE YEAR 2021 AMOUNTING TO ONE HUNDRED MILLION NINE HUNDRED NINETY THOUSAND PESOS (PHP100,990,000.00) AND ALLOCATE THE SAME TO PROGRAMS/PROJECTS/ACTIVITIES (PPAs) RELATED TO THE CORONA VIRUS DISEASE 2019 (COVID-19) PANDEMIC.

WHEREAS, on 16 April 2021, the Office of the City Mayor sent an endorsement letter to the Sangguniang Panlungsod requesting for the approval of the Supplemental Investment Program (SIP) No. 4 for the current year 2021 for the reprogramming/realignment of some infrastructure projects funded from the 20% Development Fund for Calendar Year 2021 of the City of Bacoor in the amount of **One Hundred Million Nine Hundred Ninety Thousand Pesos (PhP100,990,000.00)** and allocate the same to Programs/Projects/Activities (PPAs) related to the COVID-19 pandemic as approved by the members of the City Development Council as enumerated in CDC Resolution No. 04, Series of 2021- REALIGN SIP #4 passed on 29 March 2021;







