**A RESOLUTION APPROVING THE ISSUANCE OF AN ALTERATION PERMIT TO WHLAND DEVELOPMENT CORPORATION FOR THE BAMBOO BREEZE RESIDENCES II SUBDIVISION PROJECT LOCATED AT BARANGAY MAMBOG I, CITY OF BACOOR, CAVITE.**

**WHEREAS**, on 13 June 2016, a development permit was issued by the city government in favor of **WHLAND Development Corporation** for its WHLand Subdivision II project pursuant to City Resolution No. CR 2016-062.

**WHEREAS**, an application for Alteration Permit was filed by **WHLAND Development Corporation** involving "**Bamboo Breeze Residences II Subdivision Project**" situated at Barangay Mambog I, Bacoor City, Cavite intended to increase the number of townhouse units in the said subdivision (i.e., from 19 units to 29 units) and intended to change the project's name from WHLand Subdivision II to Bamboo Breeze Residences II Subdivision. The alteration will affect Lot 5429-A, Lot 2 & 3, Blk. 6 that covers the 2,526 square meters and are intended to make the said lots more affordable and to allow a more efficient work area for development.

**WHEREAS**, the Committee on Housing and Land Utilization, after thorough review and deliberation of the pertinent papers submitted to the Sangguniang Panlungsod and finding the application for alteration permit in conformity with the prescribed guidelines and regulations of PD 957 and other government agencies hereby recommends for the issuance of alteration permit **WHLAND Development Corporation**;
