A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF CAVITE FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR REGARDING THE IMPLEMENTATION OF THE COVID-19 VACCINATION PROGRAM.

WHEREAS, Republic Act No.11525 (the COVID-19 Vaccination Program Act of 2021) declares that one of the State's objectives is to address the adverse impact of COVID-19 through the procurement and administration of safe and effective COVID-19 Vaccines by the National Government through the Department of Health (DOH) and the National Task Force Against COVID-19 (NTF) and other duly constituted authorities and instrumentalities;

WHEREAS, Republic Act No.11525 authorizes local government units to procure COVID-19 Vaccines in cooperation with the Department of Health (DOH) and the National Task Force Against COVID-19 (NTF) and to directly procure supplies and services necessary for the storage, transport, deployment and administration of COVID-19 Vaccines;

WHEREAS, the City Government will appropriate Twenty Five Million Pesos (Php25,000,000.00) for contribution to the effort of the Provincial Government by way of donation to the Trust Fund created for the purpose of implementation of the joint vaccine procurement program of the Province of Cavite;

WHEREAS, the Office of the City Legal Officer submitted a draft Memorandum of Agreement between the Provincial Government of Cavite and the City Government of Bacoor to the Sangguniang Panlungsod for its review and consideration;
