A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORADUM OF AGREEMENT WITH THE UNIVERSITY OF PERPETUAL HELP SYSTEM DALTA AND JONELTA FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACORR REGARDING THE ESTABLISHMENT OF THE ALTA IHUB KIST PARK-SEZ INSTITUTE AT ITS SCHOOL CAMPUS LOCATED AT BARANGAY MOLINO III, BACORR CITY, CAVITE.

WHEREAS, the University of Perpetual Help System Dalta and Jonelta (UPHSDJ) has applied for permission with the Philippine Economic Zone Authority (PEZA) for the establishment of **ALTA IHUBs** on its various properties. This hub is a new form of Special Economic Zone (SEZ) under Republic Act No. 11337 to provide Research and Development (R&D) services that generate the technoscientific branches of knowledge and innovations platforms for and in the fields of architecture and engineering, business and economics, industrial technology, information technology and computing science, teacher education and social sciences.

WHEREAS, the UPHSDJ requested the City of Bacoor a No Objection Certification on the intention of UPHSDJ to establish a **KIST (Knowledge, Innovation, Science and Technology Park)- SEZ Institute** within its campus situated at Barangay Molino III, Bacoor City, Cavite pursuant to the initiative of PEZA to create another Philippine Startup Ecozone.

WHEREAS, on 26 April 2021, the Sangguniang Panlungsod passed City Resolution No. CR 2021-339A entitled: "**A RESOLUTION EXPRESSING THE CONSENSUS OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOR, CAVITE NOT TO OBJECT TO THE APPLICATION OF THE UNIVERSITY OF PERPETUAL HELP SYSTEM-DALTA LOCATED AT BARANGAY MOLINO III TO ESTABLISH A SPECIAL ECONOMIC ZONE (KNOWLEDGE, INNOVATION, SCIENCE AND TECHNOLOGY PARK) AT ITS MOLINO CAMPUS ON THE CONDITION THAT THE SAID EDUCATIONAL INSTITUTION WOULD ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE CITY GOVERNMENT OF BACOR IN RELATION TO THE OPERATION OF THE SAID SEZ**".

WHEREAS, the members of the Sangguniang Panlungsod agreed not to object to the plans of UPHSDJ to develop the **KIST (Knowledge, Innovation, Science and Technology Park)- SEZ Institute** on its Molino Campus on the condition that the UPHSDJ would agree to enter into a Memorandum of Agreement with the City Government of Bacoor.

WHEREAS, the Office of the City Legal Service, as authorized by the City Mayor, sent a draft Memorandum of Agreement to the Sangguniang Panlungsod between UPHSDJ and the city government for the city council's review and approval;

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola unanimously seconded by the rest of the council, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the 4th Sangguniang Panlungsod in regular online session assembled to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement with the University of Perpetual Help System Dalta and Jonelta for and on behalf of the City Government of Bacoor regarding the establishment of **ALTA IHUB KIST PARK-SEZ INSTITUTE** at its School Campus located at Barangay Molino III, Bacoor City, Cavite.

RESOLVED FURTHER, to furnish the City Mayor, the UPHSDJ, the University of the Philippines-Office of the National Administrative Register (UP-ONAR) and other government offices concerned with copies of this Resolution.


