A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 6 PERTAINING TO THE REPROGRAMMING/REALIGNMENT OF VARIOUS INFRASTRUCTURE PROJECTS NAMELY : 1) REPAIR AND IMPROVEMENT OF MULTI-PURPOSE HALL AND PREMISES, BACOOR CITY IN THE AMOUNT OF TEN MILLION PESOS (PHP10,000,000.00), AND 2) UPGRADING OF BRIDGE (SOLDIER HILLS) AT MOLINO VI, CITY OF BACOOR , CAVITE IN THE AMOUNT OF SEVEN MILLION PESOS (PHP7,000,000.00) FUNDED FROM THE 20% DEVELOPMENT FUND FOR THE FISCAL YEAR 2021 OF THE CITY OF BACOOR AND ALLOCATE THE SAME TO OTHER PRIORITY PROGRAMS/PROJECTS/ACTIVITIES OF THE CITY GOVERNMENT OF BACOOR.

WHEREAS, the Office of the City Mayor sent an endorsement letter to the Sangguniang Panlungsod requesting for the approval of Supplemental Investment Program (SIP) No. 6 pertaining to the realignment of the funds intended for various infrastructure projects namely: 1) Repair and Improvement of Multi-Purpose Hall and Premises, Bacoor City in the amount of Ten Million Pesos (PhP10,000,000.00), and 2) Upgrading of Bridge (Soldier Hills) at Molino VI City of Bacoor , Cavite in the amount of Seven Million Pesos (PhP7,000,000.00) funded from the 20% Development Fund for Fiscal Year 2020, of the City of Bacoor and allocate the same to other priority programs/projects/activities of the city government as approved by the Members of the City Development Council as enumerated in CDC Resolution No. 06, Series of 2021-REALIGN SIP #6 passed on 06 May 2021;
