**WHEREAS**, the Philippine Business For Social Progress, (PBSP) is the recipient of the grant provided by the Global Fund to Fight AIDS, Tuberculosis (TB) and Malaria. It is also implementing the ACCESS TB Project "Advancing Client-centered Care and Expanding Sustainable Services for TB Project (GF Project)". One of its services is to support the Department of Health (DOH) in the Philippines to scale-up the Programmatic Management of Drug-Resistant Tuberculosis (PMDT) across the country.


