A CITY RESOLUTION ENDORSING THE PURCHASE OF 18 UNITS OF MULTI CABS AMOUNTING TO SEVENTEEN MILLION THREE HUNDRED NINETY NINE THOUSAND NINE HUNDRED EIGHTY EIGHT PESOS (PHP17,399,988.00) BY THE LOCAL GOVERNMENT OF THE CITY OF BACoor, CAVITE TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) FOR THE AVAILMENT OF THE LOCAL GOVERNMENT SUPPORT FUND FINANCIAL ASSISTANCE (LGSF-FA) OF REPUBLIC ACT NO. 11518 OR GENERAL APPROPRIATIONS ACT FOR FISCAL YEAR 2021.

WHEREAS, the national government appropriated Thirteen Billion Five Hundred Eighty Five Million Two Hundred Nineteen Thousand Pesos (**PhP13,585,219,000.00**) pursuant to Republic Act No. 11518 or the "General Appropriations Act for Fiscal Year 2021" under Special Provision (SP) No. 3 of the Local Government Support Fund- Financial Assistance (LGSF-FA) shall be used for financial assistance to LGUs to support priority programs and projects of local government units (LGUs) in their locality;

WHEREAS, the Department of Budget and Management's Local Budget Circular No. 131 dated January 8, 2021 provides the guidelines and procedures on the release and utilization of the Local Government Support Fund-Financial Assistance (LGSF-FA) to Local Government Units in the FY 2021 General Appropriations Act or known as the Republic Act No. 11518.

WHEREAS, one of the projects/programs/activities included in the Local Development Investment Program (LDIP) and Annual Investment Program (AIP) of the City Government of Bacoor is the purchase of multi-purpose vehicles (also known as multi-cabs) to be used by the City of Bacoor Disaster Risk Reduction and Management Office and it was proposed by the city government to be funded under the LGSF-FA with the following specifications:
