A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE OUT-OF-HOME ADVERTISING ASSOCIATION OF THE PHILIPPINES (OHAAP) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOOR FOR THE ADVERTISEMENT OF CITY GOVERNMENT'S INFORMATION CAMPAIGN AND PROMOTION OF MEMBERSHIP TO THE ASSOCIATION.

WHEREAS, the City Legal Officer, Atty. Bernadette Carrasco, sent a letter requesting the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla to sign a Memorandum of Agreement with the Out-Of-Home Advertising Association Of The Philippines (OHAAP) regarding the partnership between the city government and OHAAP for the advertisement of the former's information campaign and promotion of membership to the association.

WHEREAS, the OHAAP is the oldest existing organization of outdoor advertising practitioners in the Philippines, having been organized in 1964 and national in its scope with chapters in Luzon, Visayas and Mindanao and with members actively operating in the City of Bacoor.

WHEREAS, the City Government of Bacoor seeks the cooperation of OHAAP in the close monitoring of its members operating in the city to ensure their compliance with the Billboard Sign Permit Regulation of the city government.

WHEREAS, the city government and the OHAAP agree to display electronic advertisements of the City of Bacoor containing information campaign in Light Emitting Diodes (LEDs) of OHAAP members within the city.
