LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MANILA ELECTRIC COMPANY (MERALCO) AND THE CITY GOVERNMENT OF BACOOR REGARDING THE ISSUANCE OF ELECTRONIC CERTIFICATE OF FINAL ELECTRICAL INSPECTION (ECFIE) OR PERMIT FOR TEMPORARY SERVICE CONNECTION.

WHEREAS, one of the requirements for the energization of buildings and other structures is the physical copy of Certificate of Final Electrical Inspection (CFEI) or Permit for Temporary Service Connection.

WHEREAS, in order to facilitate the immediate release of the connection work order pursuant to the Republic Act No. 11032 also known as the "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", the city government shall submit the CFEI or Permit for Temporary Service Connection to the MERALCO through electronic mail to avoid fraud or alteration in the permit and it will be considered by the MERALCO a valid requirement in the processing of request for energization.
