
**WHEREAS**, Section 4 (h) of the Republic Act No. 11494, or the Bayanihan to Recover as One Act, authorizes the national government to grant a "COVID-19 Special Risk Allowance" to all public and private health workers directly catering to COVID-19 patients for every month that they are serving during the declaration of national emergency.



- 3.) Bacoor Doctors Medical Center





