A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE FOR REGION IV-A REGARDING THE IMPLEMENTATION OF THE MILK FEEDING PROGRAM FOR THE YEAR 2021-2022 OF THE CITY OF BACOR .

WHEREAS, Republic Act. No. 11037 (otherwise known as the "Masustansiyang Pagkain para sa Batang Pilipino Act") was enacted to prevent malnutrition among Filipino children;

WHEREAS, RA 11037 mandates the institutionalization of a comprehensive National Feeding Program for undernourished children in Public Day Care centers, Kindergarten and Elementary Schools in view of the confirmed link between food and nutrition and the capacity of children to develop and learn;


WHEREAS, RA 11037 directed the DSWD, in coordination with the LGUs concerned to implement Supplementary Feeding Program in day care centers or in any other facility used for such purposes;

WHEREAS, Section 4(c) of RA 11037 provides that National Government Agencies (NGAs) shall coordinate with Department of Agriculture (DA), Philippine Carabao Center (PCC), and other Cooperative Development Authority for the incorporation of fresh milk and fresh milk-based food products in the fortified meals and cycle menu in accordance with RA 8172 otherwise known as the "Philippine Food Fortification Act of 2000", utilizing locally produced milk in order to enhance its nutritional content and to help the livelihood of local dairy farmers and local dairy industry.

WHEREAS, the City Government of Bacoor provides health and social welfare services to its constituents which include programs and projects on child and youth welfare, as sanctioned by Republic ACT 7160 otherwise known as the "Local Government Code of 1991";




