LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FIELD OFFICE FOR REGION IV-A REGARDING THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM FOR THE YEAR 2021-2022 OF THE CITY OF BACOOR.

WHEREAS, the Department of Social Welfare and Development (DSWD) is the government agency primarily responsible in delivering coordinated social protection services aimed at eradicating poverty;

WHEREAS, the Supplementary Feeding Program (SFP) aims to provide additional food to the usual meals of the children ages 2 to 5 years old enrolled in the Child Development Center (CWC) and Supervised Neighborhood Play (SNP) programs. It is also part of the DSWD's contribution in the early childhood care and development program of the government.

WHEREAS, the City Government of Bacoor is a partner of DSWD in the expeditious delivery of the social amelioration program and also assists in the implementation of the 11th cycle of the Supplementary Feeding Program (SFP) for the 5,000 day care children in the City of Bacoor for Year 2021-2022.

WHEREAS, funds transfer to Local Government Units is the best scheme to fast track the implementation of the program to the beneficiaries and shall be the interim solution to the malnutrition of economically disadvantaged children due to COVID-19;







